Our Mission

The San Marino Tennis Foundation (SMTF) was established in 1968 by 200 families in San Marino. Its mission is to promote tennis as a recreational activity in the community.

After its establishment, the Foundation built six championship tennis courts and a clubhouse with a pro shop and locker rooms. It then donated this facility to the city of San Marino. However, the Foundation still oversees the operation of the facility and is responsible for its maintenance.

Membership Information

Membership in the San Marino Tennis Foundation is open to all residents of the San Marino Unified School District and those who work in the city of San Marino. Members of the SMTF enjoy a variety of benefits, including:

- Use of the six championship tennis courts at Lacy Park
- Clubhouse with pro shop and locker rooms
- Online court reservation system
- Tennis activities, such as tournaments and interclub

The SMTF has two types of membership: regular and associate. Regular membership is available to residents of the San Marino Unified School District and those who work in the city of San Marino. This is subject to regular verification. Associate membership is available to those who do not meet the requirements for regular membership and may be subject to a waitlist.

Regular membership entitles immediate family members (spouse and children) residing in the applicant's home to play on the Lacy Park courts. Associate memberships apply only to the primary account holders. Spouses and children of associate members must submit separate applications.

Once your membership is approved, you will receive an email with your CourtReserve login information for the mobile app and website to make and manage reservations.

The courts are also open for play to non-members, either as a guest of a member or as a member of the general public, both for a daily usage fee of \$10 per person paid through our reservation system when applicable. A full-time professional staff is available for individual tennis instruction, and group clinics are offered for both adults and juniors at all levels of play. Tennis activities, such as tournaments and interclubs are held throughout the year.
